## Exterior Shutters

Prime Craft Shutters warrants to the original purchaser (customer) that our pre-primed substrate (Extira) is warranted against rot and splitting or cracking (exclude paint cracks) under normal conditions for a period of 5 years from the date of shipment from the Prime-Line plant. The LTD Warranty shall be void and of no affect on Prime Craft Shutters if the product is not purchased factory pre-primed. Prime-Line, Inc. shall bear no liability if product is installed and not properly finish-coated within 5 days after installation. Prime Craft Shutters that are purchased pre-finished carry no warranty with regard to the coating. Prime Craft Shutters under no circumstances will be installed where they come in direct contact with the ground or where any standing water may accumulate and, as a result, come into prolonged contact with the shutter. Shutters cannot be installed submerged in water for any reason. In no event or any circumstances is Prime Craft or Prime-Line, Inc. liable for labor, installation, reinstallation, removal, disposal charges, freight, taxes, or any other charges related to failed product. To file a claim under this limited warranty, the customer must, within 30 days after discovery of a failed product, send documentary proof of purchase and a written description of the failure to Prime-Line, Inc. in c/o Prime Shutters, 314 Reynolds Rd., Bldg 4 Malvern, AR 72104. Prime-Line, Inc. must be given a reasonable opportunity to inspect and verify the claim. This Ltd. 5-year warranty can not be changed or modified except in writing by an authorized agent of the Prime-Line,
